ORDER

Whereas as per communication of the Executive Engineer, Burdwan South Highway Division, P.W.(Roads) Dte., **the Agency**, Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368 **is responsible for underspecified/less executed quantities of different layers of road section which lead to Sub-base/base course failure and subsequently failure of bituminous layers before its design life causes innumerable loss of Govt. exchequer to the tune of Rs. 2,44,07,414.00 (Rupees two crore forty four lakh seven thousand four hundred fourteen).**

And

Whereas Superintending Engineer, Western Highway Circle No. I, P.W(Roads)Dte.& Chairman, Bid Evaluation Committee has recommended vide memo no. 1536-B/23(pt.-14) dated 27.12.2023 to take appropriate action in respect of suspension of Agency, Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368 **responsible for underspecified/less executed quantities of different layers of road section which lead to Sub-base/base course failure and subsequently failure of bituminous layers before its design life causes innumerable loss of Govt. exchequer to the tune of Rs. 2,44,07,414.00 (Rupees two crore forty four lakh seven thousand four hundred fourteen).**

And

Whereas Superintending Engineer, Western Highway Circle No. I, P.W(Roads)Dte. & Chairman, Bid Evaluation Committee has also recommended vide memo no. 1536-B/23(pt.-14) dated 27.12.2023 to recover the total claim amount of Rs. 2,44,07,414.00 (Rupees two crore forty four lakh seven thousand four hundred fourteen) from the agency, Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368.

And

Whereas 1stNotice vide memo no.631-Gen-CE/WZ-8/16 dated 28.12.2023 was served by the Chief Engineer, West Zone, P.W(Roads)Dte. & Chairperson & Convener of the Suspension Committee upon the agency through speed post as per clause 10(c) of special terms and condition vide page 13/37 of tender agreement vide tender no. 06/BS of 2017-2018 of SE/WHC-I/P.W.(Roads)Dte. in accordance with clause 4.13 of G.O. No. 547-W(C)/1M-387/15 dated 16.11.2015. But the agency or his authorised representative failed to appear before the committee stating that the agency was out of station due to critical medical emergency. But no doctor's prescription/ certificate has been attached in support of critical medical emergency except one money receipt of CK Birla Hospital CMRI, 7/2 Diamond Harbour Road Kolkata-700027.

And

Whereas 2nd Notice vide memo no. 11-Gen/CE/WZ-8/16 dated 04.01.2024 was served by the Chief Engineer, West Zone, P.W(Roads)Dte. & Chairperson & Convener of the Suspension Committee upon the agency through speed post, E-mail id-mondal.bhaskar02@gmail.com as per clause 10(c) of special terms and condition vide page 13/37 of tender agreement vide tender no. 06/BS of 2017-2018 of SE/WHC-I/P.W.(Roads)Dte. in accordance with clause 4.13 of G.O. No. 547-W(C)/1M-387/15 dated 16.11.2015. But the agency or his authorised representative failed to appear before the Committee on 11.01.2024. The agency has submitted a letter through office mail on 09.01.2024 and disagreed with the allegation made.

And

Whereas in this connection one show cause notice has also been served Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368 vide this office memo no 30-Gen/CE/WZ-8/16 dated 11.01.2024. Reply of show cause notice vide his letter no. 216/ MS/23-24 dated 12.01.2024 has been received on 15.01.2024 and letter no. 217/MS/23-24 dated 17.01.2024 received through office mail at 8.17 PM which are not at all convincing and not accepted.

And

Whereas a meeting of the suspension committee was held on 18.01.2024 in the chamber of the Chief Engineer, West Zone, P.W.(Roads) Dte and the committee had gone through the reply and after threadbare discussion it is found that reply of alleged agency is not at all convincing and made himself/themself liable for suspension in terms of **clause 10(c) of special terms and condition vide page 13/37 of tender agreement vide tender no. 06/BS of 2017-2018 of SE/WHC-I/P.W.(Roads)Dte. in accordance with clause 4.13 of G.O. No. 547-W(C)/1M-387/15 dated 16.11.2015.**


And

Whereas after a threadbare discussion in the meeting of suspension committee held on 18.01.2024, it is unanimously resolved that

- A. The Agency is responsible for underspecified/less executed quantities of different layers of road section which lead to Sub-base/base course failure and subsequently failure of bituminous layers well before its design life causes innumerable loss of Govt. exchequer to the tune of Rs. 2,44,07,414.00 (Rupees two crore forty four lakh seven thousand four hundred fourteen).
- B. The agency is hereby suspended for 6(Six) months from today (18.01.2024) to participate in any procurement process under Public Works Department for the reason of responsible for underspecified/less executed quantities of different layers of road section which lead to Sub-base/base course failure and subsequently failure of bituminous layers well before its design life causes innumerable loss of Govt. exchequer to the tune of Rs. 2,44,07,414.00 (Rupees two crore forty four lakh seven thousand four hundred fourteen).
- C. Recovery of claim due to Govt. loss amounting to Rs. 2,44,07,414.00 (Rupees two crore forty four lakh seven thousand four hundred fourteen) shall have to be made immediately from the agency Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368. with a notice of 15 (Fifteen) days, failing which legal action shall be made by the Executive Engineer, Burdwan South Highway Division, P.W.(Roads) Dte.
- D. The Suspension Committee recommends debarment of alleged agency, Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368. The case with all relevant documents is hereby forwarded to the Engineer -in-Chief & Ex-officio Secretary, Public work Department and Chairperson of Debarment Committee for debarment of the agency, Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368.

And

Thereafter, I Sri Anjan Kumar Saha, Chairperson & Convenor of the Suspension Committee, West Zone, P.W(Roads) Dte. on behalf of the Governor of West Bengal and by virtue of the power vested to me by clause 3.14 of the memorandum no. 547-W(C)/IM-387/15 dated 16.11.2015 of Joint Secretary, Public Works Department and also as per clause 10(c) of special terms and condition vide page no 13/37 of tender agreement vide tender no.06/BS of 2017-2018 of SE/WHC-I/P.W.(Roads)Dte. do hereby place the agency, Mondal Suppliers, Vill-Kalicharanpur, P.O.-Abdalpur, P.S.- Diamond Harbour, South 24 Parganas, Pin-743368. under suspension for a period of six months from the date of issue of the order, and consequent upon such suspension, the said alleged agency shall not be allowed to participate in any procurement/bidding process in Public Works Department during the period of suspension.


