Please refer to the above memos on the captioned matter, this is to inform you that after thorough examination of all the papers submitted by you for the purpose and subsequent hearing on the matter on 05.01.2023 before the Suspension Committee, the charges framed against you are found true.

It is revealed that you have violated the condition of the tender vide e-NIB mentioned above. After going through the documents, the undersigned is of the opinion that the alleged agency found to be at fault in influencing the outcome of the eligibility screening of the instant bid by submitting forged document during bidding process as per Clause 4.1, 4.2 and 4.4 of Memorandum No. 547-W(C)/1M-387/15 dated 16.11.2015 of the Joint Secretary to the Govt. of West Bengal, P.W.D., Works branch. He has committed 1st degree of offense as per above Memorandum.

Now, the Suspension Committee has recommended the suspension of the alleged agency named "R R Engineers, Near Congress Bhavan, Narayanpur, Post. - Balurghat, Dist. - Dakshin Dinajpur, Pin -733101" based on above findings.


