## **ORDER**

<u>Sub:Debarment of "Basirul Islam, P. O. – SahiSherpur, P. S – Khargram, Dist. – Murshidabad, West Bengal- 742159" from participating in any bidding / procurement in respect of all projects under Public Works Department, Government of West Bengal.</u>

WHEREAS, the meeting of Debarment Committee, Public Works Departmentwas held on 31.01.2023 at the chamber of the Engineer-in-Chief, 8<sup>th</sup> Floor, Nabanna, 325, SaratChatterjee Road, Howrah- 711102 on the matter:Allegation against the bidder - Basirul Islam, P. O. – SahiSherpur, P. S. – Khargram, Dist. – Murshidabad, West Bengal- 742159,in connection with violation of the condition of the tender for the work - 'Repair and Rehabilitation of steel bridge over River Ichamati (RakhaldasSetu) at Km. 53.53 on N.H – 112 (old N.H No.- 35) at Bongaon&Repair and Rehabilitation of steel bridge over river Naobhasan (Thakur HaridasSetu) at Km. 56.060 on N.H – 112 (old N.H No.- 35) at Bongaonon item rate mode under Annual Plan 2022-23 [Job No. – 112/WB/2022-23/497]and subsequent imposition of suspension vide Suspension Order bearing memo no. 25-CE/SOUTH/C-10(Part-III) dated 05.01.2023 of the Chairperson-Convenor of the Suspension Committee & Chief Engineer, South Zone, P.W. (Roads) Directorate thereon after conducting hearing and subsequent actions to be taken up in terms of Government order;

AND WHEREAS, the members of the Suspension Committee headed by the Chairperson-Convenor of the Suspension Committee and Chief Engineer, South Zone, Public Works (Roads) Directorate, in the meeting held on 05.01.2023, had found the agency "Basirul Islam, P. O. – SahiSherpur, P. S – Khargram, Dist. – Murshidabad, West Bengal- 742159 " guiltyas per Clause 4.1, 4.2and 4.4 of Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 of Public Works Department which has been incorporated vide clause no. 35, as a part of the e-NIB having reference no.WBPWD/ROADS/NH/SE/NHC-I/NIB-10 of 2022 -23 of Superintending Engineer, National Highway Circle – I and had placed the agency under suspension vide Memo No – 25-CE(R)/SOUTH/C-10 (part – III) Dated: 05.01.2023, of the Chairperson-Convenor of

the Suspension Committee & Chief Engineer, South Zone, P.W. (Roads) Directorate, for 6 (Six) months;

**AND WHEREAS**, the alleged bidder, "Basirul Islam, P. O. – SahiSherpur, P. S – Khargram, Dist. – Murshidabad, West Bengal- 742159" was served the notice by the Engineer-in-Chief, P.W.D. and Chairperson & Convenor, Debarment Committee, vide memo No.43-ENC/2023 dated13.01.2023 to attend the hearing on 31.01.2023 at 3:30 pm;

**AND WHEREAS**, on the aforesaid dateand time, Basirul Islam had attended the hearing before the Debarment Committee;

**AND WHEREAS**, Basirul Islam clearly admitted and confessed that the allegation against him as true and assured that such type of act would not be repeated by him in future, before the aforesaid committee:

**AND WHEREAS**, the Debarment Committeeon the basis of the facts and scrutinizing all relevant documents, unanimously decided to recommend to debar the erring agency, Basirul Islam, for 6 (six) months w.e.f. 01.02.2023, prohibiting him from participating in bidding / procurement in respect of all projects under Public Works Department, Government of West Bengal,

in terms of clause 7.1 (c)of Memorandum No.547-W(C)/1M-387/15 dated 16.11.2015 of Public Works Department, Government of West Bengal;

**NOW, THEREFORE**, in view of the above, the undersigned directed to say that the said agency, "Basirul Islam, P. O. – SahiSherpur, P. S – Khargram, Dist. – Murshidabad, West Bengal- 742159", is hereby debarred from participating in bidding / procurement in respect of all projects under Public Works Department, Government of West Bengal, for a period of 6 (six) months from 01.02.2023 to 31.07.2023 and also the said agency is hereby cautioned for not doing such act from their end in future.
