**Subject: Re-appropriation of fund during the financial year 2013-14**


Sir,

I am directed by order of the Governor to say that the Governor is pleased to provide an amount to the tune of Rs. 1,00,000/- (Rupees One Lakh only) by way of re-appropriation to the Public Works Department under the head of account "2052-00-090-NP-013-V-02-Wages" from the head of account "2059-80-001-NP-Non Plan-002-Direction – Public Works Directorate [PW] – V – 02- Wages" both under Demand No. 25 of Budget Publication No. 18 of 2013-14 and to release the said amount to meet up the expenditure under the said head of account during the financial year 2013-14.

Revised provision under the head of account "2052-00-090-NP-013-V-02-Wages" stands out to be Rs. 3,00,000/- (Rupees Three Lakh) only whereas the provision under the head of account "2059-80-001-NP-Non Plan – 002- Direction – Public Works Directorate [PW] – V – 02- Wages" stands out to be Rs. 1,79,000/- (Rupees One Lakh Seventy-nine Thousand) only.


