MEMORANDUM

Sub.: Regarding Technical Assistance of suitable domain experts for preparation of DPR.

The undersigned is directed to state that, the dedicated Engineering set up namely DPR Cell has been constituted for preparation of DPR of different Government Departments, like Food Processing Industries & Horticulture Department, Fisheries Department, Micro, Small & Medium Enterprises & Textiles Department, Agricultural Marketing Department, vide this Department Memo. No. 5959-E-I dated 13.05.2022.

The PWD is a works Department having technical expertise primarily in the field of construction of Roads, Bridges and Govt. Buildings for the purpose of creation of permanent assets.

Accordingly, consequent upon the scrutiny of requisitions submitted by various Govt. Departments, it has been observed that, different kinds of ancillary works of industrial buildings like ETP, Boiler unit, Blast freezing unit for cold storage buildings etc. and also various ancillary project works like Bank protective works on Channel, Dredging of Channel, Dredging of River/Canal, Ice plant etc. will require the technical expertise of suitable domain experts / Departments, as the PWD has no specific technical expertise related to the corresponding domains.

This may be also mentioned that, PWD does not have any domain expertise regarding layout, detailed specification, including static & dynamic loads, details of installation / fixation, capacity design of different Electro Mechanical Equipments and machineries related to various industrial buildings.

2. After careful consideration of the matter stated above, in order to reconcile amongst domains of different technical expertise, the undersigned is directed to state that, such suitable domain experts outside the domain of technical expertise of PWD, as and when necessary, whatsoever, related to various specific areas shall be provided by the concerned Client Departments to assist the DPR Cell to facilitate the preparation of detailed design, drawings and estimates.

3. The undersigned is further directed to state that, the necessary expenditure, incurred in arrangement of suitable domain experts as specified at Para-2 above whatsoever, shall be borne by the respective Client Departments for preparation of DPR.

4. This has the approval of competent authority, PWD.

5. This shall take immediate effect.
