M E M O R A N D U M

Whereas, the Executive Engineer, National Highway Division No. VI, P.W. (Roads) Directorate has been allotted three (03) numbers of hired vehicles for inspection purpose by this Department's Memo No. 1M-10/15/629-R/E dated 05.05.2015.

2. Whereas, the Baharampur National Highway Sub-Division was renamed from Jhargram NH Sub division and transferred from Quality Control Division II, P.W. (Roads) Directorate to under the control of National Highway Division VI, P.W. (Roads) Directorate in terms with the Notification No. 07 dated 21.01.2015 of the Public Works Department.

3. And whereas, no vehicle was allotted in favour of Assistant Engineer, Baharampur NH Subdivision under N.H. Division No. VI, Public Works (Roads) Directorate vide Notification No. 07 dated 06.01.2017 of the Public Works Department since the existing vehicle was lying in unserviceable condition and he is presently in need of a hired vehicle for inspection works,.

4. Therefore, the undersigned is directed to state that approval to the sanction of one (01) number of vehicle, on hired basis, since 01.02.2017 exclusively for the official use of the Assistant Engineer, Baharampur NH Subdivision for inspection of works undertaken by the office is provided, subject to availability of fund under the object head "19-Maintenance" subordinate to functional head of account for revenue expenditure related to works, and no other vehicle is presently in use with the office.

5. The drawing & disbursing with respect to this matter shall be the Executive Engineer, National Highway Division No. VI, Public Works (Roads) Directorate.

6. The total expenditure for the vehicle for each calendar month shall be limited to ₹ 25,000/-, which shall be inclusive of hiring charges, fuel consumption & Mobil oil consumption and additional charges beyond 10 hours in conformation to Transport Department's Notification No. 3564-WT/2M-81/98 dated 24.11.2008,

7. In case of journeys made by the concerned officers on holidays for official purpose a certificate shall be furnished on the body of the bill by the DDO (i.e. the Executive Engineer, N.H. Division VI in this case) that the journey was performed in the interest of public service and no separate sanction from higher authority will be required for such journey on holidays.

8. Such claims shall be drawn by submission of bill in TR form no. 26 to the respective treasury/PAO.

9. This order issues with the concurrence of the Finance Department's U.O No. Group T/2016-2017/1001 dated 31.03.2017.
