*Sub: District Wise Presentation on ongoing Road/Bridge works & Perspective Plan for
PWD, PW (R) & PW (R), NH wing.*

I am directed to intimate you that the Principal Secretary, Public Works Department will review road conditions and ongoing works zone wise from 4th week of April. The review will be held at Zonal Headquarters or at any convenient location within the respective zone.

The Executive Engineers are requested to prepare a brief write-up for each of the roads. The roads are to be described on the maps showing the important locations.

The Executive Engineers are requested to prepare road inventory for all State Highways, Major District Roads and other important roads including roads already proposed for renaming as MDR under their jurisdictions. The road inventory must include chainage-wise details of all cross- drainage structures (culverts, bridges, causeways etc.), ROW, accident prone zones (if any), zones with insufficient sight distance (if any), width constraints (if any with reason), physical existence of km post/ 5th km post/direction sign-board and any other points to be addressed for that particular road.

All Executive Engineers are also instructed to prepare *Bar Chart* of all State Highways, Major District Roads including roads already proposed for renaming as MDR and other important roads under their jurisdiction showing the location of waterways with width of waterways, stretches where any project executed during last 3(three) years with dates of completion, stretches within the DLP, stretches where projects are in progress or approved, stretches where project is mandatory to be executed in addition to the stretches in good condition.

The Executive Engineers looking after the road works of PWD, PW (Roads) and NH wing of PW(Roads)are requested to prepare a composite plan for road development in the district. A maintenance plan for the forthcoming rainy season to ensure a pot-holed/depression free road surfaces for entire highways under his control should also be prepared.


The above road inventory and bar chart should be demonstrated by *Power Point presentation*. A single composite presentation would be made by all the Executive

Engineers looking after the roads in a district. Chief Engineers of respective Zones and Superintending Engineers of the concerned Circles would have a look at the plans before it is presented to the department.

The Executive Engineers are also requested, if possible, to propose new State Highways within his jurisdiction with proper justifications considering IRC guidelines.

All concerned under his jurisdiction shall be intimated immediately so that they may initiate actions regarding the requirements. During the meeting/presentation of a district, all the Assistant Engineers looking after road sections, Superintending Engineers of the concerned Circles and Zonal Chief Engineers would remain present.

The itinerary of the plan review would be intimated in 2nd week of April.




