## **CIRCULAR**

Subject: Road restoration works, due to laying of water pipelines of the Public Health Engineering Department (PHED) on the roads belonging to the Public Works Department (PWD).

After careful consideration of the existing guidelines issued vide this office No. 1M-3/16/192-R/PL dated 17.11.2021 and this office Circular No. 1M-3/16/90-R/PL dated 22.03.2023 for laying of water pipelines of the Public Health Engineering Department on the roads belonging to the Public Works Department, it has been decided that if the laying and/or shifting of water pipelines of the PHED is inevitable on the bituminous portion of the carriageway and/or hard shoulder of the roads belonging to the PWD, the Public Health Engineering Department will deposit the restoration cost of the road to the Public Works Department as per existing guideline and after receiving the restoration cost, the Public Works Department will execute the restoration work both on the bituminous portion of the carriageway and/or hard shoulder of the roads belonging to the PWD.

This circular is applicable for laying of water pipelines of the Public Health Engineering Department (PHED) to the roads belonging to the PWD only. All other terms and conditions of the earlier mentioned guidelines will remain unaltered and operative.

This circular will take immediate effect.
